Specifically, the parent or legal guardian declares:

- She/he is aware of all the measures currently valid for the containing of contagion;
- That the child is not subject to quarantine, nor has tested positive to COVID-19;
- That none of the persons who live with the child is currently quarantined nor has tested positive to COVID-19;
- That neither the child nor people living in the same household have in recent hours had symptoms that might be attributable to COVID-19, such as body temperature above 37.5°C, repiratory difficulties, aching muscles, diaorrea, loss of sense of smell and taste;
- That neither the child nor other persons belonging to the same household have been in contact with people (family members, people at place of work, etc...) who are affected with COVID-19;
- To engage to inform the personell of the Asilo Nido if she or he has had contacts with people affected by COVID-19 at a date successive to today, in wich case the child will not attend the Asilo Nido, wether she/he presents symptoms or not, and to act in accordance to the protocol by Local Sanitary Service (ASL);
- To engage to keep the child home in the presence of fever or other symptoms such as cough, difficulty breathing, red or teary eyes, loss of sense of smell or taste, tiredeness, nervousness, vomiting, diaorrea, loss of appetite *and* to promptly inform the family doctor or pediatricean *and* personnel at the Asilo Nido about the appearance of one or more of these symptoms;
- To be aware and accept the fact that on a daily basis, the child's body temperature might be

- measured by means of a no-contact themometer before entering the Asilo Nido *and* that in case of body temperature of 37.5 or more, or of any of the above mentioned symptoms, the child will not be admitted *and* will remain under the accompanying adult's responsibility;
- To be aware and accept the fact that if fever or any of the above mentioned symptoms appear, personnel will immediatly isolate the child and inform the parents/legal tutor who must come to the Asilo Nido as soon as possible. The parent/legal tutor must in thisn case contact the family doctor or pediatrician;
- To have been adequately informed about all organisational, health and hygiene provisions for safety and for the containment of the spread of the Covid-19 infection (see the attached informative statement) with particular regards to:
 - Rules for entering and exiting the Asilo Nido;
 - That it is possible for the accomapnying adult to access exclusively to the entry hall;

In particular, the Head of the Sector for Educational and Informative Services states:

- to have given precise information concerning all organisational and sanitary measures taken to contain the spread of diffusion and contagion from Covid-19 and to engage to comunicate future modifications or integrations to provisions taken
- that all activities at the Asilo Nido are run by personnel which is adequately instructed also as far as hygiene and sanitary procedures for the containment and diffusion of contagion are concerned.
- The personnel itself, has undergone serological tests on a voluntary basis in July and in September, and is required to observe all hygienic and sanitary prescriptions and to go to their place of work only if free of any Covid-19 related symptoms;
- to engage to achieve screening procedures at the entrance to the Asilo Nido and to adopt all the neccessary health and hygiene provisions required by law, such as interpersonal distancing between adults:
- To adhere to all dipositions by the local sanitary authorities, in case of ascertained cases of Covid-19 both for children and adults at the Asilo Nido.

Signature of the present pact binds all parts to respect it in good faith.

From a giuridical point of view it does not liberate the subjects who sign it from eventual responsabilities in the case in which the regulations relating to the containment of the Covid-19 epidemic and the guidelines for the safe reopening of child education services during the period of the sanitary emergency and the ordinary regulations concerning safety on the place of work and are not respected.
